

# Yes Futures Licensed Coach (YFLC)

# Programme Overview & Key Licence Terms

### **About the YFLC Model**

The Yes Futures Licensed Coach programme recognises and supports independent youth coaches who share our mission to help young people believe in themselves. Licensed Coaches operate independently while upholding Yes Futures' standards and values.

# **Core Components**

- **1. Training & Standards** Four live training sessions (Dec–Feb) covering youth coaching practice, the Yes Futures model, engagement and motivation, and the wider youth context. Completion is required for accreditation.
- **2. Peer Support & Community** Quarterly reflective sessions, peer learning, and networking events.
- **3. Resources & Materials** Access to Yes Futures' proven coaching frameworks, session plans, and templates.
- **4. Brand & Endorsement** Use of the "Yes Futures Licensed Coach" title, logo, and digital badge, backed by a national youth development charity.

# **Key Licence Terms (Summary)**

#### 1. Grant of Licence

A one-year, non-exclusive licence to use Yes Futures' name, logo, and coaching resources within the UK. The licence runs from 1 December to 31 December of the following year (13 months), but only becomes active once all training modules are completed and the Licence Certificate and Digital Badge are issued (typically early February).

# 2. Conditions to Qualify

You must:

- Complete all required training to Yes Futures' satisfaction.
- Agree to the Brand Guidelines and Code of Conduct.
- Provide valid DBS, safeguarding training, and insurance evidence.

# 3. Your Responsibilities

• Use Yes Futures resources only for youth coaching aligned with YF's mission.



- Follow brand rules (no alterations, co-branding or misleading use).
- Maintain active insurance (£5m public liability, £1m professional indemnity).
- · Keep DBS and safeguarding training up to date.
- Take part in peer learning and reflective sessions.
- Pay the annual licence fee (£399 for 2025-26).

### 4. Restrictions

You must not:

- · Share or resell YF materials.
- · Imply employment by Yes Futures.
- Use the YF name in business titles, domains, or marketing beyond approved formats.

#### 5. Renewal & Duration

Licence renewal is conditional on refresher training, compliance review, and fee payment.

# 6. Suspension or Termination

Yes Futures may suspend or withdraw your licence for breaches, misuse, or failure to meet safeguarding or insurance requirements. On termination, you must stop using all YF materials and remove the brand from your platforms.

### 7. Data & Confidentiality

Both parties act as independent data controllers. Coaches are responsible for participant data they collect. Yes Futures retains confidentiality over training and proprietary content.

### 8. Independence

Licensed Coaches are independent practitioners — not employees or agents of Yes Futures.

# **Next Steps**

- Applications open 28 October 2025 and close 27 November 2025.
- Training runs December 2025 February 2026.
- Licences are valid to 31 December 2026.
